Introduction

Since 2011 local Forney Businesses have partnered with the Forney Arts Council to feature artwork by North Texas Artists. Partnerships with American National Bank and Lake Pointe Imaging Center are made possible by the dedication of FAC's founding Board Members and community supporters. American National Bank

Installation & Artwork Specifications

Exhibitions at ANB run year round and are a month long in duration. Artists are responsible for dropping off their artwork at the pre-arranged time. All artwork should comply with the following specifications;

- 8-16 pieces depending on the size; The bank has 4 panel sides to fill (each panel is 30 in.by 6 ft. tall.)
- Large artwork should have screw eyes or D-rings and wire for hanging
- Smaller lightweight work may have saw tooth or other attached hooks
- Wire must be fairly taut and $\frac{1}{4}$ to $\frac{1}{3}$ from the top of the piece
- Each piece of artwork may include the artists own label with price and contact information

Art must be family-friendly. Committee reserves the right not to hang art they deem unacceptable for any reason.



Payment & Donation

Payment for artwork by customers can be made with cash or check made payable to the Forney Arts Council and collected by an official FAC representative or by the designated bank employee.

At end of exhibition, FAC will collect all monies and send payment to the artist within two weeks of closing. FAC will take a donation of 20% of sales (not including sales tax) from members. **Include your sales tax on the labels so our bank helpers do not have to do any math. You are responsible for paying your own sales tax to the state.**

Art Pickup

Artists are responsible for picking up their artwork at the designated date and time. If other arrangements are necessary please speak with a Visual Arts Director in advance. Each piece must be initialed for on the entry form before leaving the bank.

Installation & Artwork Specifications

Exhibitions at Lakepointe run year round and are three months long in duration. Artists are responsible for dropping off their artwork at the pre-arranged time. All artwork should comply with the following specifications;

- Artists may show 4 large lightweight works
- Artwork may have screw eyes or D-rings and wire for hanging.
- Wire must be fairly taut and ¼ to 1/3 from the top of the piece.
- Each piece of artwork may include the artists own label with their contact information

Art must be family-friendly. Committee reserves the right not to hang art they deem unacceptable for any reason.

Art Pickup

Artists are responsible for picking up their artwork at the designated date and time. If other arrangements are necessary please speak with a Visual Arts Director in advance. Each piece must be initialed for on the entry form before leaving Lake Pointe.
